7.a Update on DAR Citizenship Ceremony

7.c Discussion on Action Steps for Building Relationships with the Community

Idea of incorporating an editorial calendar to plan out organized outreach campaigns; example: writing an article for the Insight newspaper. Another idea: tabling at Farmers Market. Will follow up with Shelley at Farmers Market to ask about availability and cost. Annie Urasky volunteered to write a draft of the Insight article by next month's May meeting. Will make sure Annie Urasky has the correct deadline for Insight content submissions.

Tiekeya Smith: Said she would be willing to have an HRC-related suggestion box in her restaurant for the group to get feedback from residents/visitors.

Rachel Andrews: Suggested the HRC should collab with the Community Engagement Board and other boards on events and activities; perhaps starting by attending other boards meetings to introduce the HRC.

The group also discussed the idea of starting to put into motion putting together a community survey. They also talked about the possibility of holding community listening sessions later in the year.
