We have recently received an application for a mural to be done on the back wall along the alley of Johnny's Speakeasy, located at 215 S Main Street.



The business owner is Chef Johnny Propolec, and he is seeking approval so that his artist (fellow dishwasher of Johnny's Speakeasy) Michael Carter, can begin painting. Johnny's Speakeasy is a popular downtown speakeasy-style bar that serves craft cocktails and small plates. The idea for the mural is to display an ancient Roman statue of a man looking down at a skull, against the backdrop of a medallion-like image. According to the artist, the mural can be put directly onto the building's black wall, or can go on a series of Wynnewood panels that can be placed onto the wall. The name of the proposed mural is 'Heavy weights the Crown.'

Should the Commission for the Arts recommend the approval of this application request to the City Commission, the City Attorney will draft a contract and licensing agreement for the project.

# INTRODUCTION

M.i.C Harder `9000

Born and raised in Detroit, Michigan, Michael Carter is a self-taught comic book , oil painter, and graffiti artist. In his late teens, he moved from Detroit to the small town of Tillatoba, Mississippi, and immediately immersed himself in the Delta blues, juke joints, Southern Folk art, and the rich history and culture of the state. Now currently in his hometown of Detroit Michigan where he reside.

After high school, Michael enrolled at Northwest Mississippi Community College where he studied graphic design and art. Michael continued to work on his art and soon developed a style of illustration all his own—graffiti and comic book elements fused with encryptions, Morse code, even Ho-Bo signs—that captures the uniqueness of the artist as well as the people and places that surround him.

Michael believes art provides not only visual pleasure, but a sense of identity for the artist as well as the viewer, and hopes to reach people on a deep and meaningful level with his work. Michael currently resides in his hometown of Detroit Michigan.







### **Overview**

The Painting Downtown Project aims to enrich the city's urban environment with artworks that reflect our community's values, diversity, and creativity. Through this program, we seek to create dynamic public spaces and foster a sense of pride and identity among residents and visitors. These Royal Oak Downtown Development Authority (RODDA) funded mural installations will add to the vibrancy and artistic aesthetics to the downtown development district, helping bolster the overall placemaking goal of the authority and further improving the district for residents, downtown businesses, and the many visitors who come downtown every year.

### **Application Process**

The process for Fiscal Year 2024-2025 (July 1, 2024 – June 30, 2025) will function as a pilot program for the placemaking initiative. High traffic areas where public engagement can assist in analyzing the program outcomes will be prioritized locations for this initial mural installation process. Private property owners seeking to be including in future mural installation programs should submit interest here (private property must be located in the DDA district, with strong preference given to the TIF District boundary of the RODDA).

Individuals or organizations wishing to create a downtown mural installation must submit design proposals through the RODDA submission form found [here](#). A rendering of the proposed mural must be included, and each artist may submit up to three views of the design from varying angles if they choose.

Artists should be prepared to make themselves available to discuss the project scope and their concept during the selection process, as needed by the Downtown Development Authority, property owner, or artwork selection committee.

### **Honorarium**

The artist(s) are required to include the cost and or projected budget in association with the work of art they submit. The artist(s) selected will each receive a deposit of 10% for materials from the full project total after the contract has been signed and prior to the execution of the selected work of mural installation. All mural installations will be awarded \$25 per square foot, less the initial deposit, upon full completion of the project installation. The initial deposit will be provided upon City Commission approval for artwork as “public art.”

Artists will be responsible for materials needed for installation including but not limited to paint, protective finishes, paint brushes or other tools for install, ladders, lifts, and insurance outlined in the artist agreement.

### **Selection Criteria**

Factors to be considered by the selection committee and RODDA staff include, but are not limited to:

- **ARTISTIC QUALITY** – Strength of artist’s concept and demonstrated technical skills and experience.
- **CONTEXT AND IMAGERY** – Appropriate imagery that does not contain explicit or vulgar imagery and words and does not contain products directly related to the business which the mural will be hosted by.
- **FEASIBILITY** – Proposals will be evaluated relative to their feasibility and convincing evidence of the artist’s ability to successfully complete the concept as proposed based on budget, timelines, and qualifications.
- **ORIGINAL** – Artists are required to warrant that artwork is their own original, unique design and that the installation of the artwork will not infringe on copyrighted materials. Commercial messaging and signage will not be accepted.
- **PERMANENCE** – Use of high-quality materials that will last a minimum of five years and are resistant to weather and ultraviolet deterioration.
- **SAFETY** - The artist shall demonstrate a plan for the safe installation of mural artwork. The supplied plan shall outline what precautions will be taken to ensure the safety of the artist during installation, as well as the public which may be nearby.

### **Program Timeline**

- **August 21, 2024:** Request for Artist Proposal Issued
- **September 3, 2024:** Request for Artist Proposal Due at 4:30 PM
- **September 4 - 5, 2024:** Select Artist Meetings with Selection Committee
- **September 16, 2024:** Selected Artists and Artworks will be presented to Royal Oak Commission for the Arts to acquire artwork approval.
- **September 18, 2024:** Artist Contracts and Funding Approval presented to the Royal Oak Downtown Development Authority
- **September 23, 2024 or October 14, 2024:** Approval for Artworks presented to the City Commission

- Following City Commission approval, artwork will be scheduled for installation in consideration of conducive weather. In instances of less than favorable weather conditions, artwork installation may be scheduled for early Spring 2025 when paint curing is more favorable for outcomes.





<b>Safety Plan (please detail safety precautions in detail)</b>	<p>In terms of the dangers presented to myself, the painter. This project does not pose many threats outside of height. To address that, the ladder I will be using is equipped with a stabilizer accessory which increases both traction on the wall and the wingspan of contact. This makes scaling the ladder exponentially safer.</p> <p>With the proposed wall being in an area of medium-heavy foot traffic, I will also set out cones around my work site in order to deter passerby from stepping within any area that could cause them harm or inconvenience, rather than from proximity to the ladder, wet paint, etc.</p> <p>To ensure that my efforts of painting only impact the project wall and not the surrounding surfaces of the building/sidewalk, I will apply heavy duty painter's tape to the building's walls/windows bordering my piece, and will work on top of drop cloths as a boundary from the sidewalk. Cleanliness is of maximum priority both in my work and my surrounding areas.</p>
<b>Longevity (please explain techniques or materials which will ensure the mural will have a long life)</b>	<p>My standard in both my studio work and public murals is for a piece to outlive myself. This requires ample consideration of longevity in regards to every step of the process.</p> <p>This begins with amply preparing the wall by cleaning/dusting/scraping it of any errant errors, followed by multiple coats of primer. During application of paint, light, even coats will be used as to prevent immediate drips and paint chipping in the future. Upon completion of the piece, multiple coats of a non-sacrificial, anti graffiti coating will be applied in order to protect the piece from weather conditions, unsanctioned tagging, and providing an easily cleaned surface for at least 5-10 years.</p>
<b>Name of Mural</b>	Inflection Point
<b>Mural Imagery Description</b>	<p>Utilizing my highly stylized, abstract shape designs, "Inflection Point" uses the setting of a reflected, super-massive mountain landscape in order to capture the "leap of faith" moment in a hero's journey. The Nomad, my character that I use to tell the tales of the human experience, is used here to represent the exhilarating feeling one gets when taking a chance on themselves to achieve greater. Seen leaping from one horizon to the next, this transformative experience is one of immense bravery and courage, and aims to instill the viewer with a powerful surge of inspiration to keep chasing their</p>
