6.a Hilzinger Block Building Historic District 108 South Main Street

6.a.1 Request for New Sign Front Facade - Farris F Haddad Law

Signage would not go into brick, but would go into mortar. Drilling would only go roughly an inch into the mortar. Substrate behind the proposed sign has not been researched. Sign Emporium is accustomed to working with historically designated structures. The signage is light with the box being made from aluminum and the lighting is LED (it could be held in one hand).

Chair Patrick Sharrik proposed a revised diagram with specific notes as to how the sign will be installed be reviewed before this is approved and the approval to be given at the next scheduled meeting in October when a new application with more precise detail as to how the signs will be hung and pull testing has been performed in order to ensure that mortar is safe for hanging of signs.
