Charter Review for the City of Royal Oak
Proposed Amendment to Chapter 3, Section 10
(Addressing Definition of Vacancy)

Section 10 - Vacancy of Seat

[Amended and adopted 11-4-1947; 7-24-2017]

A member of the City Commission shall be deemed to have vacated their seat if, at any time during their term of office, he or she:

- (a) Is absent from five consecutive regular meetings, unless the absence is excused by the Commission, by resolution setting forth such excuse and entered upon the journal.
- (b) Dies, resigns, is removed from office, moves from the City, or otherwise no longer possesses all of the qualifications for the office to which they were elected or appointed;
- (c) Is convicted by a court of competent jurisdiction of a felony, or of misconduct in office under this Charter, or is judicially declared to be mentally incompetent.

A vacancy shall also be deemed to exist on City Commission when no candidate is elected to a City Commission seat, including the office of Mayor.

ATTACHMENT 2

Charter Review for the City of Royal Oak

Proposed Amendment to Chapter 3, Section 10

(Addressing Definition of Vacancy)

Section 10 - Vacancy of Seat

[Amended and adopted 11-4-1947; 7-24-2017]

A member of the City Commission shall be deemed to have vacated their seat if, at any time during their term of office, they:

- (a) Are absent from five consecutive regular meetings, unless the absence is excused by the Commission, by resolution setting forth such excuse and entered upon the journal;
- (b) Die, resign, are removed from office, move from the City, or otherwise no longer possess all of the qualifications for the office to which they were elected or appointed;
- (c) Are convicted by a court of competent jurisdiction of a felony, or are judicially declared to be mentally incapacitated.

A vacancy shall also be deemed to exist on the City Commission when no candidate is elected to a City Commission seat, including the office of Mayor.

BALLOT LANGUAGE

**A PROPOSAL TO AMEND THE ROYAL OAK CITY CHARTER TO
EXPAND AND CLARIFY THE DEFINITION OF VACANCY OF A CITY
COMMISSION SEAT**

The proposed amendment, if adopted, would provide that a member of the City Commission will be deemed to have vacated their seat if, at any time during their term of office, they resign, are removed from office, moves from the City, is convicted of a felony or is judicially declared mentally incompetent.
