Block has not had homes demolished, speculation would be because of the lot size. 28 homes on what's now known as Lockwood (formerly Guthrie). Built by Johnston-Brommell, Inc. (Dearborn or Detroit), 1926. Builder specialized in these types of all in one developments. All 28 still stand. 2 story frame construction. 4 distinct styles: Tudor-y gables with the chimney varying in placement due to what side of the street and how much sunlight the home would receive, therefore keeping sun out of bedrooms; bungalow style; Dutch colonial; side gable with attached porch.
