The board and staff discussed the CIP planning process, and how to implement an engagement strategy in advance of the budget submission process. Superintendent McEachern noted she'd study the draft process and facilitate additional discussion at a future meeting.

Director Filipski responded to inquiries about the claims from the golf course operators that money was not allocated to the course as promised with the sale of the Normandy Oaks golf course, noting that improvements were made to the cart paths and parking lot.

He also reported that the proposed parking at Lawson Park may not be possible because the park was removed from the CDBG eligible areas.

Member Wells discussed a tour she took with the golf course operators and reported positively on the amount of activity there.

Member Abbey echoed Member Wells' sentiments regarding the golf course, and noted that he wanted to see a plan for which tennis/pickleball courts will be target for repair/replacement.

Member Wells noted that there should be a better way to measure actual use at athletic courts.

Member Burgess shared a report from the grants subcommittee which highlighted some priorities for the board and staff to consider.
