Introduction & Overview



The Mark Twain dog park was established in 2008 by the Royal Oak Animal Mission (ROAM) members. ROAM worked hand in hand with the city to identify property formerly occupied by the Mark Twain Elementary School to be designated as a dog park. The property is owned by the city of Royal Oak.

Once the land was identified the ROAM members worked diligently to raise money to purchase materials to fence the approximately five acres of the current dog park that is being utilized today. The remaining two acres consist of wooded trails for the members.

Many of the original ROAM members are no longer active with the park. Based on this the Friends of Mark Twain Dog Park was established to continue the efforts of ROAM and work with the city to make this a dog park that Royal Oak would be proud of.

There are currently over 300 paying members of the dog park. This park is used 365 days a year rain or shine. There are approximately 50 daily users of this park making this one of the most utilized parks in the city. This park is critical to the community to promote a healthy and safe space for dogs to be off-leash.

Mission Statement: Friends of the Mark Twain (formerly ROAM) dog park is a group of park members who want to ensure a safe, clean environment for dog owners to enjoy. We believe in a positive, healthy, community experience for dogs and owners.

The Friends of Mark Twain Dog Park are presenting this Master Plan to:

- Be recognized as an independent entity working to foster a collaborative relationship with the city
- Define roles and responsibilities of the park members and City of Royal Oak
- Outline recommendations for improvements to address current issues and future enhancements

Introduction & Overview



Meeting Cadence: The Friends of Mark Twain dog park will hold general member meetings on the 2nd Sunday of every month, weather permitting. Meetings will be held from 9:30 AM – 11:00 AM at the dog park, weather permitting. Roles & responsibilities: To ensure the future success and collaboration between park members and the city it is important to establish an understanding of roles and responsibilities. Currently the member fees paid by park members goes to the city of Royal Oak to pay for the following:

- Water during summer months
- Electricity for the lights
- Pet waste removal including replenishment of disposal bags via a private company
- Fence maintenance

As a city park the city also is responsible for mowing the park and parking lot snow removal.

The park members are responsible for:

- Enforcing and respecting dog park rules (see appendix E)
- Fundraising for future improvements
- Additional park maintenance not covered by the city

Membership Cost

City of Royal Oak residents pay \$40 per year and non-residents pay \$65 per year for park membership. Based on current membership (*i.e. 259 residents and 59 non-residents*) the park generates \$13,545 of income per year.

Project Implementation Plan: The following table breaks down the areas of work to be accomplished with specific action item time frames. Timeframe for completing the task:

- Immediate = within one year
- Short = 1 to 5 years
- Long = 5+ years (July 2023 and beyond)
