Notice of Construction

2025 Coolidge Highway Resurfacing Improvements

The Coolidge Highway Resurfacing Improvements project will be constructed this year on Coolidge Highway from 14 Mile Road north to the city limits. Construction is scheduled to begin in **June** and be completed by **end of August 2025**. Work is currently not scheduled for Sundays or holidays.

The contractor awarded for this work is Ajax Paving Industries, Inc. of Troy, Michigan. The city has hired Nowak & Fraus Engineers to oversee the project on behalf of the city.

Scope of Work: Construction work will include replacing some deficient curbing, milling the existing pavement, concrete road base repairs, removal and replacement of some driveway approaches and sidewalk ramps, resurfacing the roadway with new asphalt, re-striping the roadway (no changes to lane layout) and lawn restoration.

Traffic Changes:

Coolidge Highway will have one lane open in each direction throughout construction and access to businesses will be maintained.

Driveway Access: Most driveways will not be affected by this project. Commercial driveways that need to be replaced will be done in halves to ensure access at all times. Otherwise, driveway access will be maintained throughout construction.

Trash / Recycling Pickup: There will be no change in the trash and recycling schedule unless otherwise notified by the city. If you require special access for trash or dumpster pickup by a private entity, please call or email the engineering division to coordinate.

Landscaping: Where lawn areas have been damaged by the contractor's operations, the disturbed areas will be replaced with topsoil and seed. The city does not replace special landscaping, brick, timbers, plantings, fences, or shrubs placed on city's property or within the public utility easements.

Private Sprinkler Systems: Systems that encroach into the public right of way must have the sprinkler heads and lines marked by the property owner by **May 19, 2025** prior to the start of construction. **Sprinkler systems that are not marked at the time of construction and are damaged during the construction will not be repaired by the city.** The repair or replacement of damaged, unmarked sprinkler systems will be the responsibility of the property owner.

The city realizes that this construction will be an inconvenience and will work to minimize traffic conflicts and provide access to the various properties abutting the project. If a problem occurs after normal working hours, please contact the Police Department at 248.246.3500.
